COVID School Health Policy – Rachael Ricker, District Head Nurse

The number of COVID cases this fall included:

October – 4 staff; 4 students

November – 2 staff; 4 students

December - 3 staff; 5 students

January – 10 staff; 9 students

There has been no change in the district policy. Is systematic, the district requires five days unless they have a negative test or a doctors statement showing clear. COVID tests are available on each campus. Many flu cases are evident this month.

Opioid Antagonist Administration- Rachael Ricker, District Head Nurse

The December School Board approved the administration of an antagonist to be administered in emergency cases. Naloxone is an opioid antagonist that will temporarily reverse the respiratory depressive effects of opioids. When administered quickly and effectively, Naloxone has the potential to immediately restore breathing to a victim experiencing an opioid overdose. The antagonist will be administered as a nasal spray. Legislation is in place to protect user from liability. Naloxone only works on overdoses caused by opioids. This family of drugs includes prescription painkillers like OxyContin/Percocet (oxycodone), fentanyl, hydrocodone, and Vicodin, as well as street drugs like heroin. Naloxone will not reverse overdose resulting from non-opioid drugs. There is no harm if administered and not an opioid.

Two handouts were distributed concerning Fentanyl Facts and the DISD District Procedures for the Administration of Opioid Antagonist Medication. The number of fentanyl-related deaths in Texas has almost doubled in just one year. Dr. Hatt commented that the information was well written.

The district is in the process of developing materials to educate parents and students. Hays ISD has developed videos after they had four student deaths in September. Drug dogs are scheduled on campus more often and the district is considering placing vape detectors at Scott Middle School.

Mike DeHaven has been hired as the new Director of School Safety for the district. His job responsibilities include health safety as well as building security.

<u>Community in Schools Employ/ Thrive program- Jacike Melancon, Special Ed. Lead Counselor/ Behavior Support Personnel</u>

SMS Community in Schools Employee presently works with 76 students DHS Community in Schools Employee presently works with 52 students

Referrals are made by teachers/parents, and require parent permission before service can be provided. They see the student at least two times per month, with three specific goals, behavior, academics, and attendance. The funding for the program comes from Title IV funds for SMS and ESSER III funds for DHS.



Questions were asked about the Tele-Behavioral Health Program. BMc has two referrals and SMS and DHS use the service regularly. They keep a calendar and schedule at DHS. Brenda Hayward, Child and Family Guidance Center of Texoma, stated they have moved to a hybrid model and do not work with little ones using video conferences. They are serving 12,000 and have a waiting list. They are seeking new providers to grow and provide services.

Educators' Support Group- Jacike Melancon, Special Ed. Lead Counselor/ Behavior Support Personnel

Jay Sawyer @Carrus has been providing the leadership for these sessions free of charge. Sessions are provided for elementary teachers and secondary teachers, twice a month. The average attendance is about eight for each session.

Summer Professional development session has been scheduled with Dr. Rose, titled, "Anxious Much?"

P-K Toileting Policy- Regina Prigge, Director of Special Programs and Assessment

Mrs. Prigge presented procedures for students who are not completely toilet trained before they enter school. A training plan will be developed between parents and the classroom teacher to ensure that the child is on a plan of success. Parents will supply pull-ups, wipes, and an extra change of clothes. Scheduled toileting will be stopped when the child consistently initiates when he or she needs to go.

Denison is proposing a revised Toileting Policy for the 2023-24 school year. Regina Prigge provided a draft plan and stated that the SHAC would finalize the draft plan at the next meeting after members have had an opportunity to review both plans. Jerri Bone stated that the step-by-step procedures in the current plan might also be beneficial in the 2023-24 revised plan.

<u>Texas Youth Tobacco Survey- Regina Prigge, Director of Special Programs and Assessment</u>

Regina Prigge presented the information that BMcDaniel Intermediate School and Scott Middle School are two of the 200 schools in Texas selected to be part of a statewide sample for the 2023 Texas Youth Tobacco Survey. BMcDaniel, grade 6, will take the survey in February. Scott, grades 7 & 8, will take the survey in March.

All survey materials will be provided, either paper/pencil or on line version. Each campus will receive a \$300.00 payment for the completion of the survey and a full statewide report by the district. Meeting adjourned at 5:03PM



Service Hours by Tier



Contact Hours Towards Campus Goal Areas




